Website design and build

Disclosure requirements for Occupational Pension Schemes have increased over recent years. From April 2018 defined contribution (DC) and hybrid schemes must publish certain information about transaction costs, charges and other elements of the Chair's Statement.

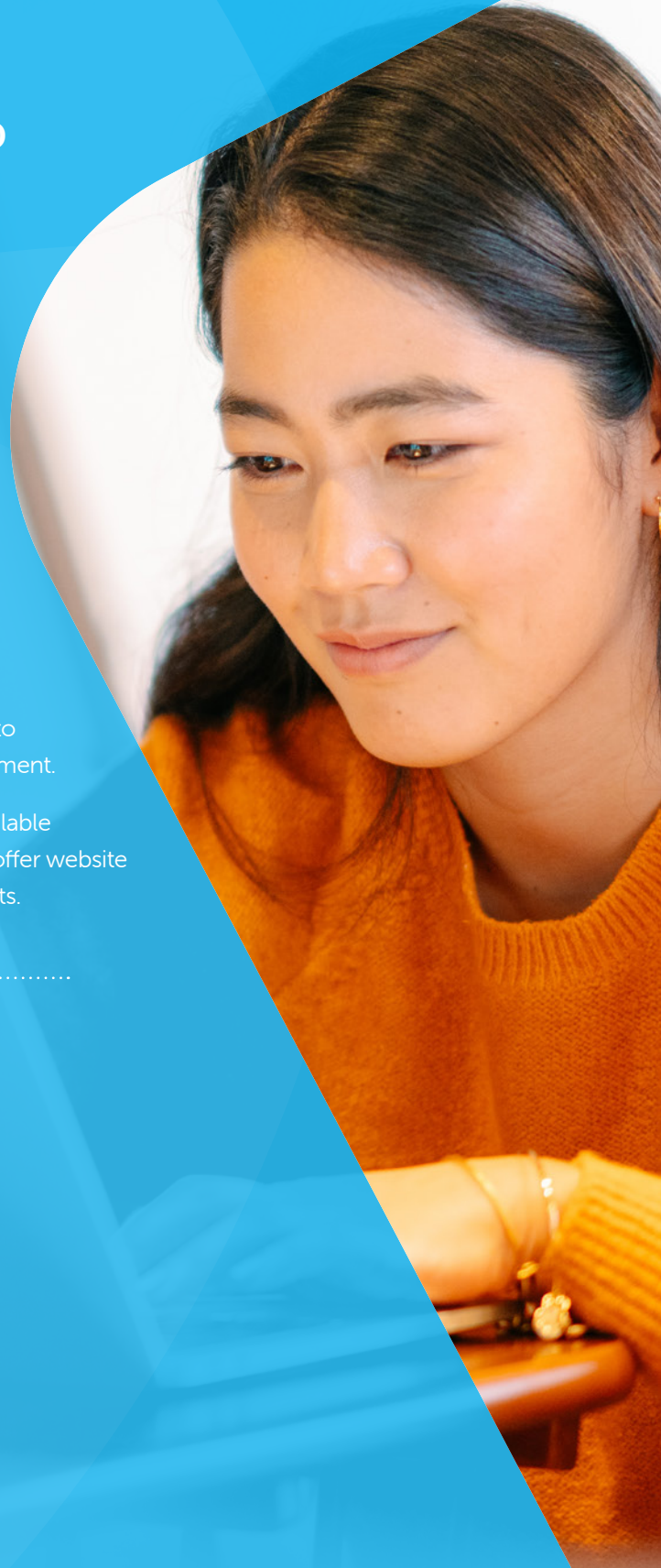
From October 2019 the requirements extended to include a requirement that trustees must produce and publish their Statement of Investment Principles.

From October 2020 the regulations will also require schemes to publish documents such as their annual Implementation Statement.

This information must be published online and be publicly available without the member having to login to a secure website. We offer website design and build services to meet these disclosure requirements.

DB SIP hosting

An option designed to satisfy the publishing requirements. We can host a PDF copy of the SIP and from October 2021 the Implementation Statement (with the SIP appended) as required under legislation.

£150 (annual fee to include upload of a new version annually and maintenance (security, SEO etc.))

DB simple website

For DB scheme trustees who wish to position their SIP within a wider context and help members understand its content. This will provide a landing page with:

- standardised intro text
- hosting of up to three pdfs
- contact details
- links to relevant sites (e.g. - member self-service, find an adviser)
- regulatory information (cookie/privacy policy)

DC simple website

A 'one' page website using our standard template (style and wording), with the following:

- Company/Scheme logo
- introductory wording, explanation of Costs and Charges, SIP, online service (if relevant)
- store page which hosts DC Chair Statement and SIP
- contact details
- links to relevant sites (e.g. Member self-service, provider site, find an adviser)
- regulatory information (cookie/privacy policy)

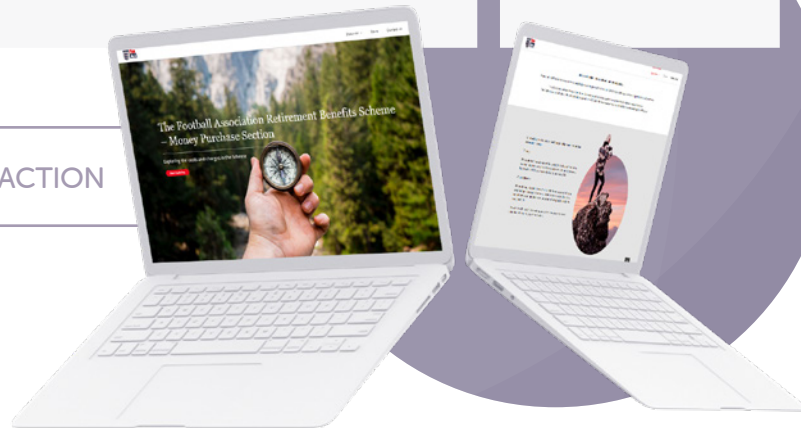

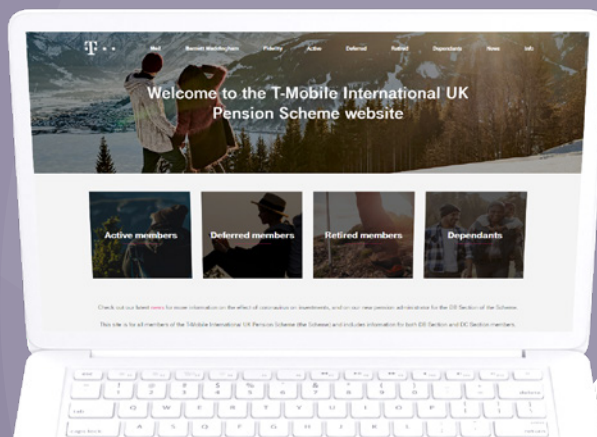
INVOLVE

Third parties

Where relevant, our preference is to work in conjunction with third parties (for example the scheme provider) to ensure members are getting a consistent message and we don't risk over-communication or confusion.

Assumptions

- All fees exclude VAT.
- Depending on which option, this proposal does not, unless otherwise stated, include publishing information on Costs and Charges or illustrations based on these beyond publication of the Chair's Statement. Also calculation of costs are not included.
- These services also do not cover any of the wider DC governance requirements including assessment of value for member and drafting of the Chair's Statement.
- Additional ad-hoc work would be charged at time cost (hourly rates range from £142 - £319).
- Fees include two sets of amends, additional amendments would be charged on a time cost basis.
- Any revamp of the website in future would be looked at as a new project and costed at that time.
