




# Helping shape Sustainable tutures





#### Sustainable investment policy setting

Monitoring reports include:


- Sustainable investment ratings of investment managers

# Strategy

## Climate scenario analysis

Our climate scenario analysis assesses assets (and liabilities if applicable) in line with requirements under the Occupational Pension Schemes (Climate Change Governance and Reporting) Regulations 2021. The analysis focuses solely on climate-related attributes and combines a mixture of qualitative and quantitative assessment, considering each of the underlying investment's unique characteristics.

The analysis is built around two key metrics (the Climate Risk Impact Score and Climate Opportunity Score) and a range of climate scenarios.

The output from our analysis sets out how an investment portfolio performs against each of the metrics and climate scenarios, allowing you to compare these characteristics. We also consider how each of the underlying investments perform relative to their respective asset classes.





# Implementation

## Investment manager sustainable investment ratings

The sustainable investment rating has been designed and assessed by the Manager Research Team and Sustainable Investment Team. The rating is made up of three sub ratings:

- Sustainable investment research
- Sustainable investment integration
- Stewardship

The rating is the outcome of a qualitative discussion by all members of the Manager Research Team where the managers' sustainable investment approach is discussed in the context of the full fund.

The overall rating and underlying sub-ratings will take the form of high conviction, acceptable and low conviction, as defined below.


# Climate Risk Impact (CRI) score scale

Expected potential per annum CRI over the long term allowing for physical and transitional climate risk.




# Climate Opportunity (CO) score scale

Considers a fund's ability (in terms of the assets it may invest in) to take advantage of opportunities that may arise from climate change.
